Part 1: MOBILE PAYMENT – BILL OF ENTRY

The MRA Customs is pleased to offer its valued stakeholders the opportunity to now pay, without any service fee, their Bills of Entry electronically via their mobile phones through the MauCAS.

Once a Bill of Entry requiring payment up to one hundred thousand rupees is validated, the importer or declarant can proceed to pay the duties and taxes electronically from the MRA Website as follows:

Bill of Entry Payment:

1. Login Screen

Navigate to MRA website www.mra.mu and select e-services and click Customs
